 g. NO LIVE Rodent/ Mammal/ Bird sales allowed.

2. Permits and Taxes:
 a. Each vendor is responsible for obtaining the proper permits for sales.
 b. Each vendor is responsible for paying the appropriate local, state, & federal taxes based on their sales.

3. Alcohol or Smoking is not permitted in the building.

4. Vendors shall hold Reptile Super Show, the show coordinators, and staff, harmless from all claims beyond the price of the booth fee. Reptile Super Show, show staff, and convention center staff reserve the right to refuse entry or evict any vendor not in compliance with the above rules and without refund for the booth fee.
